Searching the NNTT Registers in New South Wales

Search service

On request the National Native Title Tribunal will search its public registers for you. A search may assist you in finding out whether any native title applications (claims), determinations or agreements exist over a particular area of land or water

In New South Wales native title cannot exist on privately owned land including family homes or farms.

What information can a search provide?

A search can confirm whether any applications, agreements or determinations are registered in a local government area. Relevant information, including register extracts and application summaries, will be provided.

In NSW because we cannot search the registers in relation to individual parcels of land we search by local government area.

Most native title applications do not identify each parcel of land claimed. They have an external boundary and then identify the areas not claimed within the boundary by reference to types of land tenure e.g., freehold, agricultural leasehold, public works.

What if the search shows no current applications?

If there is no application covering the local government area this only indicates that at the time of the search either the Federal Court had not received any claims in relation to the local government area or the Tribunal had not yet been notified of any new native title claims.

It does not mean that native title does not exist in the area.

Native title may exist over an area of land or waters whether or not a claim for native title has been made.

Where the information is found

The information you are seeking is held in three registers and on an applications database.

National Native Title Register

The National Native Title Register contains determinations of native title by the High Court, Federal Court and other courts.



Register of Native Title Claims

The Register of Native Title Claims contains applications for native title that have passed a registration test.

Registered claims attract rights, including the right to negotiate about some types of proposed developments.

Register of Indigenous Land Use Agreements

The Register of Indigenous Land Use Agreements contains agreements made with people who hold or assert native title in an area.

The register identifies development activities that have been agreed by the parties.

Application summaries

An application summary contains a description of the location, content and status of a native title claim.

This information may be different to the information on the Register of Native Title Claims, e.g., because an amendment has not yet been tested.

I refer to your correspondence, dated 20 January 2012, to the Environment Protection Authority (EPA) concerning the Aboriginal heritage assessment located within the Maitland LGA and described as a proposed Aboriginal Cultural Heritage Assessment for the Mt Arthur Coal Open Cut Modification.

Please find enclosed a list of known Aboriginal parties that the EPA considers is likely to have an interest in your project. I note this is not necessarily an exhaustive list of all interested Aboriginal parties. Receipt of this list does not remove the requirement for a proponent/consultant to advertise the proposal in the local print media and contact other bodies and community groups seeking interested Aboriginal parties, in accordance with the 'Aboriginal Cultural Heritage Consultation Requirements for Proponents 2010' (CRs).

The EPA would also like to take this opportunity to remind the proponent or consultant of a number of key issues we have been encountering of late, and we'd ask your organisation to take note and ensure compliance please. These issues include:

- Please ensure the project documents the full consultation process in the Aboriginal cultural heritage assessment report or Aboriginal Heritage Impact Permit application and to include copies of all correspondence sent or received from all relevant stakeholders (including Aboriginal stakeholders and the agencies listed in section 4.1.2). Omission of these records in the final report may cause delays in approval or require parts of the consultation process to be repeated if the evidence provided to the EPA does not demonstrate that the consultation process has been fair, equitable and transparent.
- Unless the EPA is provided with evidence that reasonable attempts have been made to contact the relevant parties associated with the CRs, then the EPA will deem that the consultation process has not been complied with.
- The EPA considers evidence of reasonable efforts to contact relevant parties would include, but not be limited to, multiple forms of communication; faxes (with confirmation slips demonstrating successful transmission), an e-mail log, registered post details, copies of letters and a phone call log.

- Please note Appendix A of the CRs contains a map illustrating the region of the EPA to contact according to which local government area your project falls within. Full details of the consultation requirements and the relevant Fact Sheets can be located on our website at: http://www.environment.nsw.gov.au/licences/consultation.htm.
- If you encounter any changes to the contact details of interested Aboriginal parties, or become aware of additional parties, we encourage you to forward this information to the EPA so we can update our records.
- Consultation must be fair, equitable and transparent. If the Aboriginal parties express concern
 or are opposed to parts or your entire project, the EPA expects that evidence will be provided
 to demonstrate the efforts made to find common ground between the two perspectives.

Thank you for this opportunity to comment on the Proposed methodology for Mount Arthur Coal Open Cut modification. Like all areas in the Hunter Valley the land, vegetation and water ways hold cultural significance to the Aboriginal community. Both oral and European written history tells us that the area was resource rich, the land being very fertile, the flats open and grassy the hills well treed.

This area is in close proximity to the song line, Mount Arthur being one of the guiding markers, and a cross roads between the routes to the coast, the Sydney basin, Western Plains, the Northern Tablelands and possibly the Lithgow region. It is also in easy walking distance to a number of known ceremonial areas. Yes the area around here is very significant, perhaps even more so by this being the area of the last stand of the local inhabitants against the invading whites' occupation, theft, kidnappings, rapes, murders and domination. In 1826 after fighting broke out there between Wonnarua and Kamilaroi people and settlers. The local tribes retreated into the swampy scrubland around Mount Arthur to conduct guerrilla warfare against the settlers in one of Australian's many frontier wars. When the white settles found they were unable to combat the resistance, the government of the day was contacted for aid and assistance. The settlers received arms ammunition and military support which led to the destruction of the Aboriginal resistance. Some of the elders tell of being taken by their parents and grandparents and having much of their early traditional teaching done here. There was at the time many of the traditional food sources and resources to be found within easy walking distance of the town of Muswellbrook, still very much as it was before European settlement.

I note with disappointment that there is planned to destroy sites within areas set aside as a cultural offset. The areas are contained within the grid references, 9318, 9518, 9323, 9523 on the 1:25,000 Muswellbrook topographical map 9033-11-N-64. Area one is the Mount Arthur North Edderton road Archaeological Conservation area approx 122 Ha in size, area two is approx 21 Ha and part of the Bayswater #3 Archaeological Conservation area.

These areas are less than 4% of the area to be destroyed BHP Billiton's Mount Arthur North open cut mine and were set aside as a representative sample of the Aboriginal Heritage resource that existed in the region. As Koettig and Thorp (1990:8) identified, "There are no reserves or National Parks in the Central Lowlands within which some sites would be preserved, there is urgent need to address the problem of site destruction and preservation before more of the resource is eroded." At the time of writing in 1990, 77% of all known sites had already been destroyed in the Central Lowlands area. For these reasons these two areas along with two others were set aside as conservation areas. These remanent areas are of great significance to the Aboriginal community.

This is unacceptable. Wanaruah LALC has a responsibility to the 3000 plus Aboriginal people living within our boundaries to protect their culture on their behalf. We regretfully cannot stop the destruction of the many areas of significance that mining companies want to destroy. But we will not idly stand by and let anyone destroy a protected zone.

We do not accept nor agree with the methodology recommendations for the Mount Arthur Coal Open Cut modification and will not accept them without the guaranteed protection of ALL the Existing MAN Heritage protection Zones.

Thank you for the opportunity to review the above draft report dated 9 August 2012.

It was disappointing that we were not included in the surveys undertaken in March 2012 and instead, four other groups participated who were not prepared to divulge their identity (Name withheld A to D). We can only hope that they are prepared to reveal themselves to the other Aboriginal stakeholders in their reviews of this report and continuing consultation.

Although Wonn1 did not participate in the surveys we generally accept the 9 recommendations with the following addition and comments:

With regards to Recommendation 3, Wonn1 has concerns with the temporary Keeping Place in the "proposed Thomas Mitchell Drive Offset Area" as Mt Arthur Coal continues to allow outside agencies etc. (including Ausgrid, Muswellbrook Council) to excavate the Offset Area infrastructure placement, when this land is supposed to be protected from disturbance. It would be preferable for the location and temporary storing of artefacts to be discussed with the Aboriginal Stakeholder groups first.

Additional Recommendation 10

In the event that stone artefacts are unearthed during civil works undertaken by Mt Arthur Coal or its contractors, work must cease immediately in the affected area and the NSW Office of Environment and Heritage (OEH), a suitably qualified archaeologist and the Wanaruah LALC are to be informed. Work cannot commence in that area until appropriate management strategies have been addressed.

We look forward to be given the opportunity to continue the consultation process with your organisation in the near future.

In relation to your first request, a copy of the draft Aboriginal Cultural Heritage Assessment report is attached. Wanaruah Local Aboriginal Land Council (WLALC) was originally sent a copy of the draft Aboriginal Cultural Heritage Assessment report on 8 August 2012. Following your request on 19 September 2012, an additional copy was emailed to the WLALC at wanaruah@bigpond.com by RPS Australia on 19 September 2012.

In relation to your second request, Hunter Valley Energy Coal (HVEC) is unable to grant an extension to the report's comment period at this late stage. As noted in previous correspondence to the WLALC, the period for comment was open from 8 August to 5 September 2012 and the final report has now been prepared.

By the close of the comment period, 41 Aboriginal cultural heritage stakeholders, including WLALC, had registered their interest in the modification project and were subsequently invited to be involved in the field survey and preparation of the report. In addition, Aboriginal stakeholders, including WLALC, were invited to an information day onsite to discuss the findings of the Aboriginal Cultural Heritage Assessment. HVEC received no other requests for the comment period to be extended.

Although any late comments would be unable to be included in the report, I would welcome any comments you may have, which would be included in the consultation log for the Aboriginal Cultural Heritage Assessment. A formal response would also be provided to the WLALC Board.

HVEC remains committed to consulting widely with Aboriginal stakeholders, including the WLALC. In the past this has included undertaking comprehensive consultation about the Thomas Mitchell

Drive offset area and, as shown in the attached summary, the modification project extension areas. I would like to assure you that this commitment will continue in the future.

Glossary of Site Types



Glossary of Site Types

The following is a brief description of most Aboriginal site types. Most of these do not occur in the immediate Modification area although are provided for regional context.

Artefact Scatters

Artefact scatters are defined by the presence of two or more stone artefacts in close association (i.e. within fifty metres of each other). An artefact scatter may consist solely of surface material exposed by erosion, or may contain sub-surface deposit of varying depth. Associated features may include hearths or stone-lined fireplaces, and heat treatment pits.

Artefact scatters may represent:

- camp sites: involving short or long-term habitation, manufacture and maintenance of stone or wooden tools, raw material management, tool storage and food preparation and consumption;
- hunting or gathering activities;
- activities spatially separated from camp sites (e.g. tool manufacture or maintenance); or
- transient movement through the landscape.

The detection of artefact scatters depends upon conditions of surface visibility, including vegetation cover, ground disturbance and recent sediment deposition. Unfavourable conditions obscure artefact scatters and prevent their detection during surface surveys.

Bora Grounds

Bora grounds are a ceremonial site associated with initiations. They are usually comprise two circular depressions in the earth, and may be edged with stone. Bora grounds generally occur on soft sediments in river valleys, although they may also be located on high, rocky ground in association with stone arrangements.

Burials

Human remains were often placed in hollow trees, caves or sand deposits and may have been marked by carved or scarred trees. Burials have been identified eroding out of sand deposits or creek banks, or when disturbed by development. The probability of detecting burials during archaeological fieldwork is extremely low.



Culturally Modified Trees

Culturally modified trees include scarred and carved trees. Scarred trees are caused by the removal of bark for use in manufacturing canoes, containers, shields or shelters. Notches were also carved in trees to permit easier climbing. Scarred trees are only likely to be present on mature trees remaining from original vegetation. Carved trees, the easiest to identify, are caused by the removal of bark to create a working surface on which engravings are incised. Carved trees were used as markers for ceremonial and symbolic purposes, including burials. Although, carved trees were relatively common in New South Wales in the early 20th century, vegetation removal has rendered this site type extremely rare. Modified trees, where bark was removed for often domestic use are less easily identified. Criteria for identifying modified trees include: the age of the tree; type of tree (the bark of many trees is not suitable, also introduced species would be unlikely subjects); axe marks (with the need to determine the type of axe - stone or steel – though Aboriginal people after settlement did use steel); shape of the scar (natural or humanly scarred); height of the scar above the ground (reasonable working height with consideration given to subsequent growth).

Fish Traps

Fish traps comprised arrangements of stone, branches and/or wickerwork placed in watercourses, estuaries and along coasts to trap or permit the easier capture of sea-life.

Grinding Grooves

Grinding grooves are elongated narrow depressions in soft rocks (particularly sedimentary), generally associated with watercourses, that are created by the shaping and sharpening of ground-edge implements. To produce a sharp edge the axe blank (or re-worked axe) was honed on a natural stone surface near a source of water. The water was required for lubricating the grinding process. Axe grinding grooves can be identified by features such as a narrow short groove, with greatest depth near the groove centre. The grooves also display a patina developed through friction between stone surfaces. Generally a series of grooves are found as a result of the repetitive process.

Isolated Finds

Isolated finds occur where only one artefact is visible in a survey area. These finds are not found in apparent association with other evidence for prehistoric activity or occupation. Isolated finds occur anywhere and may represent loss, deliberate discard or abandonment of an artefact, or may be the remains of a dispersed artefact scatter. Numerous isolated finds have been recorded within the Modification area. An isolated find may flag the occurrence of other less visible artefacts in the vicinity or may indicate disturbance or relocation after the original discard.



Middens

Shell middens comprise deposits of shell remaining from consumption and are common in coastal regions and along watercourses. Middens vary in size, preservation and content, although they often contain artefacts made from stone, bone or shell, charcoal, and the remains of terrestrial or aquatic fauna that formed an additional component of Aboriginal diet. Middens can provide significant information on land-use patterns, diet, chronology of occupation and environmental conditions.

Mounds

Aboriginal mounds are places where people lived and reflect a record of that living space. Mounds may be places where Aboriginal people lived over long periods of time. Mounds often contain charcoal, burnt clay or stone heat retainers from cooking ovens, animal bones, shells, stone tools and occasionally Aboriginal burials.

Mythological / Traditional Sites

Mythological and traditional sites of significance to Aboriginal people may occur in any location, although they are often associated with natural landscape features. They include sites associated with dreaming stories, massacre sites, traditional camp sites and contact sites. Consultation with the local Aboriginal community is essential for identifying these sites.

Rock Shelters with Art and / or Occupation Deposit

Rock shelters occur where geological formations suitable for habitation or use are present, such as rock overhangs, shelters or caves. Rock shelter sites generally contain artefacts, food remains and/or rock art and may include sites with areas of potential archaeological deposit, where evidence of rock-art or human occupation is expected but not visible. The geological composition of the Modification area greatly increases the likelihood for rock shelters to occur.

Stone Arrangements

Stone arrangements include lines, circles, mounds, or other patterns of stone arranged by Aboriginal people. These may be associated with bora grounds, ceremonial sites, mythological or sacred sites. Stone arrangements are more likely to occur on hill tops and ridge crests that contain stone outcrops or surface stone, where impact from recent land use practices has been minimal.

Stone Quarries

A stone quarry is a place at which stone resource exploitation has occurred. Quarry sites are only located where the exposed stone material is suitable for use either for ceremonial purposes (e.g. ochre) or for artefact manufacture.

RE: Heritage Significance and Impact Assessment Report for Fence and Yards Items within Mt Arthur Open Cut Modification Area

Please find set out below the findings of our heritage significance assessment of the fence and yards site at the base of Mount Arthur. This is followed by an assessment of the likely heritage impact of proposed mining expansion activities and mitigation recommendations. This report is structured as follows:

The site in question is the remains of a post and rail timber fence running roughly east to west adjacent to the track leading to Mount Arthur accessed off Denman Road and the nearby remains of a loading ramp and stockyard fencing. It is located to the southwest of the Mt Arthur Open Cut Mine and the majority of the post and rail fence remains are within the proposed Mt Arthur Open Cut Modification Area (refer to Figure 1). The remains of the loading ramp and stockyard fencing are outside of the Mt Arthur Open Cut Modification Area. The site is described in more detail in Section 3.0. This report has been prepared in accordance with *The Burra Charter: The Australia ICOMOS Charter for Places of Cultural Significance* (1999) using New South Wales (NSW) State heritage significance criteria.

1.0 EXECUTIVE SUMMARY

- The remains of stockyards and a post and rail fence were identified in a Heritage Impact Assessment Report prepared in 2009 for the Mt Arthur Coal Consolidation Project. The items are described as having "Little significance within a local context due to poor condition".
- A review of historic parish maps shows that the site on the slopes of Mount Arthur is likely to have belonged to Ann Black from at least the late 19th Century as part of the gradual subdivision of the Edinglassie Estate.



- The stockyard remains comprise the remains of a loading ramp and stockyard fencing crudely constructed from logs and branches tied together with wire. Both structures are in a state of collapse. These are later structures than the post and rail fence.
- The post and rail fence remains run for just under 700 metres (m) and consist mainly of heavily weathered posts with two rail slots in varying degrees of collapse with many fallen and heavily eroded on the ground. A limited number of very weathered, bowed rails remain in place.
- The structures have been assessed against the NSW State heritage significance assessment criteria. The stockyard remains are considered to be of negligible heritage significance. The post and rail fence is evidence of historic rural land use and would have been an impressive structure displaying technical achievement when in a better condition. It is considered, however, that the fence's heritage values have been compromised by its poor condition.
- The fence is considered to be beyond repair and given its poor condition, its significance is considered to lie solely as a record of an historic allotment boundary. It is considered that the recording of the fence line (as per Figure 1) mitigates against any adverse impact created by the loss of the fence.

2.0 REVIEW OF EXISTING STUDIES AND HISTORICAL RESOURCES

Mt Arthur Coal Consolidation Project Non-Aboriginal Heritage Impact Assessment (Archaeology Australia, 2009)

Several reports have been prepared with regard to the Aboriginal and European cultural heritage resource within the Mt Arthur Mine site area. It is understood, however, that the first time the land on which the fence site is located was assessed was in 2009. The report which identified the site is the 'Mt Arthur Coal Consolidation Project Non-Aboriginal Heritage Impact Assessment' prepared by Archaeology Australia (2009).

The Archaeology Australia report refers to the site as 'Fence and Yards' and describes them as the remains of a fence line and stock yards. They are described as consisting of numerous extant posts with no rails located and a makeshift loading ramp. The yards are noted as being located in the corner of the paddock bounded by the post and rail fence. They are assumed to have been temporary yards because living trees are used as corner posts. They are also noted as being later than the fence because galvanised steel wire is used in their construction.

The condition of the items is described as poor with the timber posts decaying. The archaeological potential of the site is considered to be nil. The heritage significance of the item is assessed as "Little significance within a local context due to poor condition". It is noted that the item meets two of the NSW State heritage significance criteria, namely aesthetic/technical value (criterion (c)) and value in potential to yield further information (criterion (e)).

With regard to historic context, the report explains that the survey area originally formed part of the Edinglassie Estate, a station created in 1824 through land granted to George Forbes, brother of the Chief Justice of the Colony, Dr Francis Forbes. It is noted that 2,000 acres of land on the slopes of Mount Arthur within the Estate was subdivided in 1910 into six lots and sold at auction. It is not confirmed in the report whether this subdivided land is the location of the fence and yards site.



The mine consolidation proposals considered in the Archaeology Australia report did not impact upon the fence and yards site and as such, there was considered to be no impact on their heritage significance.

Historic Parish Maps of Brougham from 1892 - 1923

Mount Arthur and environs is located within the Parish of Brougham and a review of historic parish maps from 1892 to 1923 indicates that the land around Mount Arthur has been subdivided since at least the late 19th Century. The parish maps are of insufficient detail to determine exactly under which ownership the land on which the yard and fence remains are located. It does appear, however, that the land belonged to an Ann Black.

3.0 SITE SURVEY FINDINGS

Figure 2 shows the extent of the remains of the post and rail fence as well as the location of the loading ramp and stockyard fencing remains. As highlighted earlier, the loading ramp and stockyard fencing remains are located outside of the proposed Mt Arthur Open Cut Modification Area. The post and rail fence remains cover 694 metres and in part run alongside the Mount Arthur access road behind a later post and wire fence and then continues down the slope of the paddock with a section beyond a small reservoir rising up a short section of another slope.

Plates 1 to 6 below show the appearance of the remains of the fence, stockyard fencing and the loading ramp. The loading ramp and stockyard fencing remains are crudely constructed structures made from logs and branches tied together with wire. Both structures are in a state of collapse.

The posts of the post and rail fence are heavily weathered and many have been subject to insect attack. A significant number have fallen over completely or are in the process of doing so. There are a number of rails in situ as can be seen in Plates 3 and 5 below; however, these are also in a very weathered and deteriorated condition. Although in very poor condition and in a state of partial collapse, it is clear that the post and rail fence was a substantial, well-made structure. The posts and rails are made from ironbark and through examination of the post bases it is clear that they are in their original position. Measurements of the remains indicate that the average height and width of the posts are 1.26m and 21 centimetres (cm) respectively and posts are on average 2-3m apart.

Pickard (2009) defines a post-and-rail fence as, "A fence using two to four (split) rails fitted into mortises in (split) posts with the ends of adjacent rails overlapping in the mortises." With regard to dating such structures, Pickard (2005) notes that colonists built post and rail fences in areas settled up to about 1860 but they were not common because of cost and the fact that shepherds rather than fence, controlled stock until the 1850s. Imported wire available from the 1850s marked the death knell for post and rail fences and they were considered to be obsolete technically by 1900. They continued to be used; however, with farmers building them in decreasing numbers up to the 1960s.









4.0 HERITAGE SIGNIFICANCE ASSESSMENT

The poor condition of the fence and yards remains has a bearing on an assessment of their heritage significance because of the amount of fabric lost and the advanced stage of deterioration. The NSW Heritage Significance Assessment Guidance identifies gradings of significance to be used in evaluating the relative contribution made by different components of a heritage place. They are a useful guide in determining whether criteria are satisfied but may need to be modified to suit particular sites. Each grading is listed and described below:

 Exceptional: Rare or outstanding element directly contributing to significance and consequently, fulfils criteria for local or State listing.

High: High degree of original fabric and demonstrates a key element of an item's

significance and consequently, fulfils criteria for local or State listing.

Moderate: Altered or modified elements with little heritage value but which make some

contribution to significance and likely to fulfil criteria for local or State listing.

Little: Alterations detract from significance. Difficult to interpret and as such, does not

fulfil criteria for local or State listing.

Intrusive: Damaging to the item's heritage significance and as such, does not fulfil criteria

for local or State listing.

An assessment of the heritage significance of the fence and yards item against NSW State heritage significance criteria (NSW Heritage Office, 2001) is provided below.

NSW State heritage significance criterion	Response
(a): An item is important in the course, or pattern, of NSW's cultural or natural history (or the cultural or natural history of the local area)	Historic fencing provides information on the history of rural land use. It is understood that the land associated with the fence and yard remains was part of a subdivision of the Edinglassie Estate dating from at least the late 19 th Century belonging to an Ann Black. The fence has some historic value as a record of an historic land subdivision.
(b): An item has strong or special association with the life or works of a person, or group of persons, of importance in NSW's cultural or natural history (or the cultural or natural history of the local area)	There is no evidence to suggest that the site has particular associative value with individuals or groups of persons of cultural historic importance.
(c): An item is important in demonstrating aesthetic characteristics and/or a high degree of creative or technical achievement in NSW (or the local area)	The loading ramp and stockyard fencing are crudely constructed and are not considered to fulfil this criterion. The remains of the post and rail fence indicate that it was a substantial and well made structure. The scale and extent of the fence as well as the use of ironbark suggests that significant resources were employed. Post and rail fences which were well made such as this

	one demonstrate technical achievement. However, the dilapidated condition of the fence and the advanced stage of its deterioration have a bearing on whether this criterion is satisfied. In effect, the fence has lost its technical value because it could not be repaired meaningfully due to the level of fabric loss and deterioration.
(d): An item has strong or special association with a particular community or cultural group in NSW (or the local area) for social, cultural or spiritual reasons	There is no evidence to suggest that the site has community/social or spiritual value.
(e): An item has potential to yield information that will contribute to an understanding of NSW's cultural or natural history (or the cultural or natural history of the local area)	There is no evidence to suggest that the site has particular 'scientific interest' such that the fence and stock yard remains could provide information that could not be found at a more intact site elsewhere or through documentary evidence.
(f): An item possesses uncommon, rare or endangered aspects of NSW's cultural or natural history (or the cultural or natural history of the local area)	It is understood that post and rail fences were never common because of their high cost and the ubiquitous use of shepherds (Pickard, 2005). As such, it is considered that intact, historic post and rail fences are likely to meet this rarity criterion. As noted above, however, the advanced stage of the fence's deterioration means that its heritage significance has been compromised and this criterion is not satisfied.
(g): An item is important in demonstrating the principal characteristics of a class of NSW's (or the local area's) cultural or natural places; or cultural or natural environments	In a more intact form, it is considered that this criterion may well be satisfied on the basis that post and rail fences are considered to be iconic symbols of rural Australia.

5.0 IMPACT ASSESSMENT & RECOMMENDATIONS

It is understood that the land in which the post and rail fence remains are located will become an extension of the existing Mt Arthur Coal open cut mining operation as part of the proposed Mt Arthur Open Cut Modification Area. As such, the removal of the items in questions will be necessary.

As discussed above, the poor condition of the post and rail fence due to the advanced stage of deterioration and level of fabric loss means that its integrity and value in heritage terms have been undermined. Looked at practically, the structure has reached such an advanced stage of decay and dilapidation that consolidation and repair is not considered feasible. Indeed,



restoration or reconstruction by introducing modern material alongside existing fabric is also not considered practicable. Consequently, the heritage significance of the fence remains is considered to rest solely in that it is evidence of an historic land subdivision, assumed to be land holdings dating from the 19th Century belonging to Ann Black.

The loss of the fence remains will have a minor, negative heritage impact. It is considered, however, that this can be mitigated through recording of the subdivision line marked by the fence remains. This is shown in Figure 2.
