Public Environmental Review/Draft Environmental Impact Statement Proposed Outer Harbour Development, Port Hedland Western Australia (Public Review Period: 18 April – 13 June 2011)

BHP Billiton is growing in the Pilbara to meet increased global demand for iron ore. To accommodate this growth, BHP Billiton Iron Ore is seeking Government approval to build a new port, the proposed Outer Harbour at Port Hedland, Western Australia.

The Office of Environmental Protection Authority (EPA) determined that the Proposal required assessment at the level of Public Environmental Review (PER) under the Western Australian Environment Protection Act 1986 (EP Act). The then Commonwealth Minister for the Environment, Heritage and the Arts determined that the Proposal (EPBC2008/4159) is a controlled action under the Commonwealth Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act), and is to be assessed by the Department of Sustainability, Environment, Water, Population and Communities (DSEWPaC) at the level of Environmental Impact Statement (EIS). The controlling provisions under the EPBC Act are Sections 18 and 18A (listed threatened species and communities), Sections 20 and 20A (listed migratory species) and Sections 23 and 24A (Commonwealth marine areas).

A coordinated assessment under both the EP Act and the EPBC Act is to be undertaken for this Proposal, based on the one environmental assessment document. BHP Billiton has prepared and published for public review a single PER/Draft EIS in accordance with Western Australian Government procedures under the EP Act and in accordance with Part 8, and published for public review in accordance with Section 103, of the EPBC Act.
