Environmental Management

Kangaroo Management




Figure 1 Example of Kangaroo Management Zone

On April 8 MAC conducted the first kangaroo harvest in approximately 10 years. The Management Program involves harvesting kangaroo carcasses for human consumption and includes the opportunistic shooting of feral animals such as dogs and rabbits. To date MAC has removed 1573kg of kangaroo meat from site, with the program continuing on throughout the calendar year. Areas being focused on include the onsite offsets and VD1 Rehab, as Figure 1 below.

FY19 Rehabilitation Update

The FY19 rehab target has been modified following discussions with the Resources Regulator. The FY19 rehab target was initially for 90ha. A substantial part (>40ha) of the target is the Main Dam and North Cut Tailings Dam. This is a complicated piece of work and in the process of planning the work to be completed safely and to the highest standards the completion date has been pushed back until FY21.

Bulk shaping and topsoiling was completed in VD4, VD5, CD2 and Saddlers Central (40ha). Additional bulk shaping was completed in the Drayton Void area and Saddlers South (9ha). Additional areas were dumped to the final elevation allowing for a total of 90ha of dump transitioning into the rehabilitation phase. 16ha was completed to seeding in the Saddlers West and VD5 areas. The seeding methodology was improved by using drones to aerially seed these locations, improving in seeding spread and safety. All available areas will be seeded as conditions allow for an increased chance of rehabilitation success.

Environmental Performance

Air Quality Monitoring (Period 1 April to 30 June 2019)

- This paper (for the reporting period of 1 April 2019 to 30 June 2019) covers the performance of all six statutory PM₁₀ monitoring sites using TEOMs, and the two dust deposition gauges identified above.
- 7 days within the reporting period experienced elevated absolute PM₁₀ TEOM monitoring results. These events (Table 1 below) were investigated accordingly, finding the incremental MAC contribution not exceeding the impact assessment criteria contained within the Project Approval. The investigations were provided to the NSW Government Department of Planning and Environment (DP&E). No exceedances reported for deposited dust. Deposited Dust (DD) graphs for DD08 and DD14 have been included in this report in line with the MAC Air Quality Management Plan.


Sheppard Avenue – DC02







South Muswellbrook - DC04







Roxburgh Road - DC05







