

## F I X T U R E S

In order to start the ball rolling, a Football Team has been formed, and the following Matches have been arranged, viz:-

29.7.22 B.H.P. v. Union Bank at Amateur Sports Ground.  
 5.8.22 B.H.P. v. Col. Mutual Ins. Co. at Royal Park.  
 12.8.22 B.H.P. v. Commonwealth Bank at Brunswick.  
 19.8.22 B.H.P. v. Nunawading Diggers at Box Hill.  
 26.8.22 B.H.P. v. A.M.P. Society at Brunswick.

The first Match proved a victory for the Union Bank, which was more or less anticipated, since the majority of our men were "green" having had only a few days' notice to prepare for the Match, and were thus in need of training.

The Match proved very exciting throughout, and we gave the Bank a "good go" up to half time, after which the Union Bank Team gradually forged ahead, and won, the scores being 15-20 to 6-5.

Messrs Rees, Edwards, A. Brown, Longney, Newham, Islip, and Sugden played exceptionally fine football, and the goals were distributed amongst Messrs. Matthews (2) Longney (2) & Newham (2).

On the 5th August, a further Match was played against the Colonial Mutual Insurance Coy., and the spectators had the pleasure of witnessing a game which gave us an overwhelming victory, the final scores being B.H.P. 13-19, Colonial Mutual Insurance Co. 2-5.

Although the opposition was undoubtedly weak, we were very gratified with the result, for it proved that the outing on the previous Saturday, together with the extra training derived during the interval, had worked wonders with the Team, and when they settle down, if all goes well, we should be a very hard Team to beat next Season.

"True Boot Artists" were provided in Messrs. Longney (4) goals, Milne (2), Sutherland (2) Harder (2) Newham (1) Rees (1) Islip (1) and a good deal of comment has been made regarding the merit of Messrs A. Brown, Berling, and Sugden.

A Football Match was played on the Old Brunswick Ground on Saturday, 12th August, between the Company's Team and The Commonwealth Bank. The game was commenced in a drizzling rain, which continued intermittently during the afternoon. Owing to the wet conditions prevailing, the ball was difficult to handle, marking, especially proving to be no easy matter.
